e) Central Region Representative, Don Scott:

AGM of Federation is October 15th at N. Woodside with a dance to follow. The new dance flooring will be at the Maritime Convention in Charlottetown.

> g) DANS: Dottie's "Squares, Contras and More" school education kit is available through the Education Media Department.

h) Canadian National: Bob & Inge:

Each invited to take away a package of CSRDS information and various posters. - Total Society membership for 2011 is 12,619 members

- Premium for Liability Insurance increased by 10% this year.
 - (This was after several years with no increases.)

- The Liability Insurance for each year begins only from 1 January. New dancers coming to the activity are not covered until they are included in the next year's insurance policy. Additions to the membership can be made until the end of February.

- Teen-age dancers 19 years or younger receive free Society membership. Clubs must list the number of these teen dancers so that Society membership cards can be provided.

- Federations/Associations/Festivals/Clubs/Leaders must submit their current NS Federation membership forms and monies by the NS due date of 31 October each year.

- It has been re-emphasized that if dancers see errors or changes required on the Society webpage, www.squaredance.ca they should be reported to the Provincial Directors.

- The Society call-in number 1-866-206-6696 is being answered by a dancer in BC. She relies on the Society webpage to provide the information to answer questions coming to her. NS clubs are encouraged to include the 1-866-206-6696 number in their advertising.

- Four Long Service Awards were presented to leaders and dancers.

- The Society has a very attractive lapel pin for sale (\$3). Contact the NS Directors.

- The CSRDS has awarded 17 Bursaries to Callers/Cuers attending Schools in 2011, including 3 from NS. Funding was also provided to one Caller school.

- The next National Festival - Festival 2014 in Ottawa is hoping to attract 2000 dancers. Four hotels are offering convention rates from \$129 to \$199. Newsletter #2 is available.

- The Society has initiated a fund-raiser for the square dance victims of Jap's Earthquake/Tsunami disasters. Canadian dancers/clubs/associations/federations are asked to donate up to the end of this year. Cathy Langille has volunteered to process the funds. Each NS club should have received a flyer explaining the appeal. To date, NS has donated \$1300.

- The Society Board will be holding AGM 2011 in Montreal on 22 October.

- Society is considering a badge to show which provinces a dancer has danced in.

- Newfoundland square dancing now is only to records in St. John's.
